## **QUESTION 2**

Mpho wants to buy a house and goes to a show day for a new town house. She does not have her Identity document with her and so the salesman tells her to return the next day to sign the contract. She is worried that other people will buy the house, and so she asks the salesman to enter into a verbal agreement to sell the house to her. He agrees and she hands him E1 000 deposit. He issues her a receipt and she goes home. The next day she returns and the house has been sold to someone else. Advise her.

Jolwane goes to the store and pays E50 towards the debt from his own money. He promises to pay the whole amount within a week. After a month Jolwane has still not paid the debt. Advise the Store-owner of his legal position as regards the minor.

# **QUESTION 6**

In the case of *Lammers and Lammers v Giovannoni* 1955 (3) SA 385, the credit receiver of a car sold it to another person who stripped it, and sold the chassis yet to another person. The credit grantor, still the owner, succeeded in regaining possession of the car. The dispossessed buyer called on the seller to assist him in defending his claim, but the seller did not do so.

The court held that once the seller had failed to come to the assistance of the buyer, the seller was not able to claim that the buyer should have been more vigorous in the buyer's defence of possession.

Discuss the law pertaining to a dispute of this nature, the legal issues in this case, as well as the basis of the court's decision *in casu*.
