Question 2

Pedro then persuades Max that they must enter into a contract where Max will sell the safety clothing to the construction company at half the awarded tender cost, being 4 Million Emalangeni, or else he will make sure that his past will haunt and destroy his new found love and marriage.

Emmanuel who is Sam's partner in the business realizes that at 4 Million they will barely be able to supply all the safety clothing as required and let alone make any profits, and advises Sam that this new deal from the contract he has signed with Pedro is not good for their business.

Max having sleepless nights knowing what happened approaches you and seeks advice on what can be done to resolve the problem before him.

With reference to case law, advise Sam of the legal issues that are raised in this case.

His Grandmother says let him go ahead and close the deal at E1, 5Million.
