KLM Electronics, a subsidiary of KD Electronics, is a retailer of home electronic items. KLM has grown rapidly in the past three years. Starting with a single store, there are now six stores in four towns employing 150 people. The most distant store is 135 kilometers from the home office.

Each store has two personal computers serving as cash registers that operate on-line via phone lines back to the main office. When clerks enter sales data, a receipt is printed and the cash drawer opened. Other operations including payroll, accounts receivable, accounts payable, purchasing and inventory are also computerized. All buying is done centrally at the main office.

An employee recently quit and took a copy of the price book containing price and cost information on all 1000 items carried in the stores. For the first time management has become aware of the need to provide security for sensitive information.

As a first step you have been called in to perform an internal audit/investigation of information security. Top management has promised full cooperation in this effort.
