The Gripper Brake Company is a small new manufacturer of brakes, brake linings and other parts of braking systems. It sells approximately 100 different sizes of brake products to garages and retail outlets of motor vehicle products in all regions of the country. Gripper generated sales revenues last year of E15 million. Moreover, Bheki Sibiya, the owner and manager of Gripper, foresees rapid growth in sales during the coming years. Mr Bheki has become aware that the firm is having difficulty in processing increasing number of sales orders and delivering orders to customers by promised dates. When customers inquire about the status of their orders, clerks often must spend hours tracking down the answers. Critical parts and materials needed in the manufacturing of products are frequently out of stock. Losses from bad debts have been increasing at an alarming rate. The firm is also having difficulty in meeting the weekly payroll and in preparing the required government payroll tax reports.

These problems have led Mr Bheki to seek help from Sipho Dube, the firm's accountant. After a careful investigation, Sipho recommends that the firm aquires its own computer system. On agreement from Mr Bheki, he investigates further and proposes 10 microcomputer systems which should be linked to form a local area network (LAN).
