iii) Define the Substitution test. Apply the Substitution test to the subject of one of the trees you drew in (i) and give the result. [4 marks]

iv) Define truth conditions. Are the truth conditions of the sentences you gave in (i) and (ii) the same or different? Explain your answer. [9 marks]

v) What is the difference between the sentences you gave in (i) and (ii)? Indicate the difference in predicate-argument structures between the two sentences. [6 marks]
