QUESTION 1

a) In October 2014, private investigators from Zwemart accosted Mr Phila Buthelezi (MP) and his girlfriend, Ms. Cebile Ngwenya in an apartment that belonged to the latter. They (private investigators) are alleged to have broken into the flat and took pictures of the two lovers inside the bedroom. The pictures were handed to the *Times of Swaziland* which published the story and the pictures.

Discuss whether the publication of the story was ethical or not.

b) According to the Magistrates Court Act of 1938, any person, including journalists, can be subpoenaed to give evidence or to produce documents in their possession. You have already promised your sources confidentiality but the court wants you to reveal the sources of your story.
