#### **QUESTION 1**

Mfanzile Dlamini is a staunch member of a community of people who embraces the belief that the birth of a child who has some deformities is bad luck, so the child must be abandoned in a secluded place immediately. They assert that this has been a customary practice which they have inherited from their forefathers.

It was on the basis of this belief that Mfanzile took his 3<sup>rd</sup> wife's child who was born with a cleft palate and left her in a forest. Mfanzile was convicted after Cinisile Hlongwane raised an alarm on discovering the child in the forest.

In mitigation, Mfanzile stated that this was a practice that the community in which he came from have always upheld and respected. They saw nothing illegal about it as their forefathers practiced it too.

You are assigned to convene a meeting with members of Mfanzile's community and explain to them, amongst other things, the recognition and application of customary law in Swaziland.
