#### QUESTION 1.

Occasionally, in the conduct of a criminal trial, counsel will deal with a hostile and/or an intransigent witness. Criminal procedure provides for mechanisms that counsel must follow in dealing with either witness. Discuss the said mechanisms and proffer recommendations on how the law may be improved.

### **QUESTION 2.**

Mary Shaw is fifteen years old. She is charged with the offence of murder in that on or about the 13th June, 2011, and at or near Fairview, Manzini, she intentionally and unlawfully killed one Brenda Seven, a female minor aged sixteen years. The bone of contention is that the accused was a girlfriend of the deceased and they were in love relationship-however unconventional. The deceased is said to have communicated to the accused her intention of ending the love relationship, and in her words-"because the accused was lousy in bed." This infuriated the accused who proceeded to stab the deceased once on the chest with a bread knife which was on the kitchen table when the altercation began. The accused is an unsophisticated minor who has been kept in custody for almost a year now. She has languished in custody simply because the system forgot her. Your attention has been drawn into this case and, as an expert in criminal procedure you agree to help. What will your first action be, if the accused must be assisted to get out of her incarceration so she can pursue her education?

Draft the necessary papers to help the accused person in this matter.

The Protection of Witnesses' Act has made radical inroads in the manner witnesses will now be catered for in our criminal justice system. Do you agree? Give reasons for your answer making reference to authorities.
