## **QUESTION ONE**

Sbhasana Ndlovu is the elected member of the Mtsambama Inkhundla. During a debate of the Bill on ARVs distribution in the country, MP Ndlovu moved a motion that all HIV positive people should be branded so that they can be easily identifiable. Some members of the House were greatly annoyed by this motion while others stated that there was nothing wrong with it. A confrontational debate ensued between the two factions and MP Ndlovu stepped down under pressure from the protesting members who were now on the verge of manhandling him. During the confrontations, MP Ndlovu manhandled the member of Dvokodvweni Inkhundla, MP Sikelela Dlamini, who is a well-known enemy of Ndlovu.

The Speaker failed to maintain order, and security forces were called in to calm the situation. The session for the day was adjourned unceremoniously. MP Sikelela Dlamini was seen rushing out of the House, bleeding profusely from the nose from the injury he had sustained from MP Ndlovu's blows during the confrontation.

Two days later, whilst sitting at the canteen in Parliament, MP Ndlovu was laid a criminal charge by the Lobamba Police. MP Dlamini had laid a charge of assault with intent to cause grievous bodily harm against MP Ndlovu on Count One. Dlamini had a huge cut on his cheek caused by the huge diamond rings on Ndlovu's fingers. Count Two was a charge for causing chaos in the House by initiating a discriminatory motion, knowing very well that some members of the House were also HIV Positive.
