#### **<u>QUESTION 1</u>**

The People of Mtsambama Inkhundla are aggrieved that their elected member of Parliament (MP) is never seen around the constituency anymore since his election to parliament. He is now a Cabinet Minister under the Ministry of Home Affairs. The people are complaining that he had promised to erect proper infra-structure around the constituency should they elect him to Parliament.
