He met D with whom they acquired a property wherein they built their dwelling home. D took a mortgage bond with FNB Swaziland and paid for the property, however it was registered in the name of A. A and D lived together until A met his untimely death in a car accident, in 2014. B alleges that the property in question must be collated into the estate of A.

Critically analyse the case, giving legal advice on all the issues raised therein.

Lihle and Simile were married in community of property in 1980. Three children were born as a result of the marriage. Lihle was an astute civil engineer during his lifetime and retired in 2005. Lihle and Simile ran a successful kombi business and flats business. In 2017, Lihle fell ill and was diagnosed by the doctors at Mbabane Government Hospital to be suffering from prostate cancer. In November 2017 Lihle executed a will in the presence of Nokwanda, who was his mistress. Nokwanda signed the will as a witnesses and it was lodged at the Master's office. In the will Lihle bequeathed the trucking business and flats business to Nokwanda. Lihle succumbed to his illness in February 2018 and aged 90. Simile alleges that the will is invalid and has approached you for legal advice.
