## **QUESTION 1** (Compulsory)

Spudd, is the owner of the Coconuts Restaurant, specialising in traditional Mozambican Cuisine. He offers to sell the restaurant to Paddy for E1 million. Paddy says: 'I can't afford more than E750 000.' Realising that Paddy may change his mind about the deal, Spudd replies: "Paddy, this restaurant is a gold mine! It's a busy location, and if you devote your full attention to the business you will achieve a gross turnover of well over a million every month." This statement convinces Paddy to buy, but for E50 000 more. Spudd accepts the E800 000 and the sale is concluded. Paddy spends an extra E200 000 refurbishing his new restaurant.

After running the restaurant for three months, Paddy discovers that the business is located in very quiet area. Only 5 regular customers come in per day. Moreover, when Paddy examines the business' accounting books he discovers that Spudd had never managed to obtain a turnover of more than E200 000 per month.

Discuss all legal issues and advise Paddy as to his rights, obligations, and possible remedies. In your answer, refer to case law.
