The ladder provided by "modern plumbers" is too old and and collapses. Shangani falls ninety feet to the ground receives multiple injuries to the head, chest and limbs. An ambulance is called and Shangani is driven to hospital but dies on the way. It also transpires that the newly qualified nurse who attended Shangani in the ambulance did not provide him with oxygen which was available.

Advise the widow.

### **QUESTION 3**

A vehicle insured by Maswati Insurers collided with Sibandze. As a result of a major injury, Sibandze was in a permanent vegetative state, unaware of all bodily functions, blind, mute and deaf. He was 100% disabled with no prospect of recovery.

His father and natural guardian wishes to sue for damages, in his personal capacity and also in his son's behalf, advise him, illustrating your answer with decided cases.
