OUESTION ONE (COMPULSORY)

Central to the Hart-Devlin debate is the never-ending question whether the law, as a social control, should be used to enforce morals. In this regard, reference is being made to the English case of *Shaw v The Director of Public Prosecutions* [1961] 2 All E.R. 446 (HL) which it is assumed you have read and are familiar with its facts and conclusion.

Basing your argument on the Wolfenden Report, and the debate that followed between the two legal titans (Lord Devlin and Professor Hart), discuss how the debate presented itself in the case of *Shaw v The DPP*, as competing with the law. Take a position and indicate whether you agree or disagree with the conclusion reached. Avoid a lengthy repetition of the facts of the case.
