QUESTION 1

Silondzi Imvelo, is a Non-Governmental Organization (NGO) whose responsibility is to conserve and protect the environment. The NGO also helps litigate in cases of environmental degradation and where environmental crime is committed. The NGO has its offices in Manzini area in the Manzini region. In October 2017, the residents of kalaMgabhi complained about a company that had set up shop in their area. The residents stated that the company was polluting the water from the only river they had in their area. They also complained about the effluent that the company was emitting into the air. They stated that they now suffered from recurrent respiratory diseases and a variety of cancers all traceable to the pollution of their environment by this company. As with most rural communities, this community was poor and did not have the means to institute proceedings in court, not that they knew this could be done. Having heard about these complaints, Silondzi Imvelo, decided to take up the matter on behalf of the kalaMgabhi community. They approached the High Court for a remedy. Defence Counsel argued that the NGO had no locus standi to prosecute in this matter as it did not comply with provisions of the Criminal Procedure and Evidence Act, 1938 and the Constitution as it is only the Directorate of Public Prosecutions who is dominus litis in the prosecution of criminal matters. You represent the NGO, first identify the relevant provisions the Defence Counsel is raising and then proceed to fully respond to their argument.

What is the effect of a plea of guilty in criminal proceedings?

QUESTION 3

Sigcino Mweli is charged with the offence of murder in that on or about the 18th May, 2009, and at or near Mliba, Manzini, she intentionally and unlawfully killed one Sarah Bart, a female aged sixty years. She denies she committed the offence. She instead alleges that it was committed by her identical twin sister who escaped for a neighbouring country soon after the offence. Birth records at the Mliba Clinic confirm that she is a twin and this fact is also common knowledge within her community. The accused is an unsophisticated person who has been kept in custody for almost 7 years now. She has languished in custody simply because the system forgot her. Your attention has been drawn into this case and, as an expert in criminal procedure you agree to help. What will your first action be, if the accused must be assisted to immediately get out of incarceration pending the setting of a trial date?
