QUESTION 5

Read the case study below and answer the set questions. Do not add to the facts in the case study

Hlengiwe is a 9 year-old HIV positive girl who lives in Ngudzeni. She is doing grade 4 at a local public school and has to stop going to school because there is no one to pay for her school fees and is constantly ill. Both her parents died from AIDS-related illnesses.

Her parents left her with no money as they had spent all of their money on medication. Hlengiwe's relatives approached the local education authority asking it to waive her school fees but were told this was not possible. They have also tried to get assistance from the local clinic but were informed that the clinic was not an accredited health care facility to assist parents with access to antiretroviral drugs (ARVs). They turned to a local HIV/AIDS organisation for help but were told that while Hlengiwe's situation is unfortunate, their mandate was limited to assuring care and support for people living with HIV. Furthermore, the HIV/AIDS organisation could only help Hlengiwe with regards to care and support but not access to treatment. They then turned to a local NGO. Edu-Action for assistance, and this NGO had a long list of children needing its support.

Hlengiwe's family met and decided that they had done all they could do and that Hlengiwe should be sent to Manzini where she can easily find employment as a domestic

helper. They also realised that Hlengiwe had a better chance of accessing treatment in the city. A few months later, Hlengiwe is subsequently employed as a domestic helper in the city.

Answer the following questions with reference to the legal instruments relating to the protection of children's rights such as the CRC, the Constitution of Swaziland, the Children's Protection and Welfare Act, 2012 and other related laws:

(a) Identify five (5) the human rights abuses that have occurred in Hlengiwe's life since her parents' death.

(b) Identify the rights and the sources of the rights which are infringed by the human rights abuses in this case study.

(c) Explain how these rights have been infringed and discuss who is responsible for protecting and enforcing these rights.
